Verbal Presentation – Library Programs for Seniors

The Chair, Councillor Russ Cook provided a verbal presentation on the library programs for seniors. The programs / services include:

- *Get Connected* is a digital literacy class aimed at members of the community who are struggling with or feel challenged by technology. Classes include using a smartphone, cybersafety, photography, searching the Internet, using library resources such as Borrowbox and Linked In Learning, setting up an email account;
- Get Connected One on One provides one on one help with a library tech expert;
- *Home Service* where library materials are selected for members of the community who are housebound. The library items are personally delivered to the community member's home;
- Bulk Loan Service to Aged Care Facilities is an extension of the Home Service. A selection of reading material to cater for all interests is selected and delivered to approximately 12 of Townsville's aged care homes;
- Local History and Heritage service aids people with family and local history research;
- free document scanning and emailing used by over 60s to access government and nongovernment organisations' services and resources, such as social security; and
- Aged Care Reform Information Pods at Riverway and Aitkenvale sponsored by funding from the Federal Government to provide information for over 60s.

- Future offerings – 2024

Library staff will be considering new offerings to assist in providing increased opportunities for seniors to connect and engage across the branches.

- Seniors Garden;
- intergeneration programs;
- targeted wellbeing programs;
- connection programs;
- Dementia focus;
- information sessions eg money matters;
- The Older Entrepreneur; and
- Senior City Podcast.
